The Louisiana Department of Transportation and Development is currently conducting a Supplemental Environmental Impact Statement (SEIS) process for the I-49 Lafayette Connector. This is the third public meeting in the SEIS process.

— Proposed End-to-End Concept Refinement Alternative that includes:

- Kaliste Saloom Interchange Area
- University/Surrey Area
- Pinhook and South Ramp Pair
- Willow Interchange and North Ramp Pair

— Two Sub-Alternatives

- E1 Evangeline Thruway Core Area Couplet
- M1 Mainline Core Area Tangent Alignment with 30-foot Vertical Clearance

— Other Considerations

- Potential Bicycle and Pedestrian Enhancements
- Conceptual Street Cross Sections
- Potential Traffic Calming Measures
